

**"DRAGON BALL Z DOKKAN BATTLE" 11TH ANNIVERSARY PART 1
CHARACTER PREDICTION CAMPAIGN
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. ELIGIBILITY.

The "'DRAGON BALL Z DOKKAN BATTLE" 11TH ANNIVERSARY PART 1 CHARACTER PREDICTION CAMPAIGN" ("**Promotion**") is open to individuals who are at least eighteen (18) years of age or the age of majority in their state (whichever is older), as of the start date of the Promotion. Employees of Sponsor and its affiliates, vendors, and their respective immediate families are not eligible to enter this Promotion. If the winner is found to be ineligible, Sponsor reserves the right to award the prize to another participant and to require the return on any prize already rewarded. 3. HOW TO ENTER.

- 2) During the campaign period, post your prediction for the 11th Anniversary featured character on X with the hashtag "ComingDokkan11th".

When predicting the featured character, please include [Character/ Series / Form].

If the correct character is Super Saiyan Goku (GT), entries that stated "Goku / GT / Super Saiyan " will be accepted!

*Entries that list only "Goku" will be considered incorrect.

You must complete all steps to be entered.

Limit of one (1) entry per person. Only the first post made during the campaign period from each X account will be eligible for entry.

Entries generated by a script, macro, or other automated means will be disqualified. Any attempt to enter two (2) or more times, including but not limited to using multiple accounts, will result in any such additional entry to be treated as a void entry. Incomplete, unreadable, or unintelligible entries will be disqualified. All information provided by entrants becomes the property of Sponsor.

4. ODDS OF WINNING.

Odds of winning depend on the number of eligible entries received.

In case of failure of any winner to provide required information within the specified time period, of noncompliance with the foregoing requirements, or if a winner cannot accept a prize as specified by Sponsor, the prize will be forfeited. In the event of a prize winner forfeiture or disqualification, Sponsor will randomly select an alternate winner.
